Throughout this past year, we have welcomed many new individuals into the WSA family, both within Residential and Day Services. We are so inspired and grateful for the unique experiences and gifts that each person brings along with them.

Along with new individuals, we have also had several incredible new staff members join our team this year, including our new Director of People and Culture, Sheri Grist, and John Alexander, our new Manager of Business & Operations for our Empties to WINN and GreenGoods programs.


Our Mindful Hearts Training program has continued to pick up momentum. Along with ongoing training of WSA staff, we continue to receive requests to bring this combination of best practices for supporting people with developmental disabilities and those facing the challenges of aging and dementia, from all around the province. Thanks to funding provided by the Stollery Family Foundation, we will be hiring a Mindful Hearts Supervisor in 2019 to continue to evolve the Mindful Hearts Training program.

Subsequent to year-end, we received notification that our grant request from the Community Facilities Enhancement Program (CFEP) grant through the Government of Alberta was approved. The grant will be used to renovate the kitchen space in WSA's main building, to create a new and functional industrial style kitchen. This new space will be available to people receiving support from WSA, the general public for social functions, as well as providing a community kitchen program organized by WSA for local community members.

WSA will also be taking over the remainder of the main building when Norquest leaves in the fall of 2019. With the additional space, we look forward to offering more opportunities for collaboration and partnership with local residents, and other non-profit organizations in the Community and Social Services Sector, as we create our Community Resource Centre.

# Empties to UINN green goods

The WSF was established as a fund exclusively for the benefit of persons with disabilities in the Province of Alberta.

Incorporated in 1972 under the Societies Act of Alberta, it works closely with the WSA by providing financial support for projects and initiatives aimed towards improving the lives of adults who are supported by the Association. The fund was named after Dr Winnifred Stewart, a recipient of the Order of Canada for her dedication to providing care and support for people with disabilities.

Fundraising by the WSF works to advance the WSA's Mission and Vision and to develop relationships with community and corporate supporters.

Throughout the year, fundraising activities are implemented by the WSF team in four areas:


- Social Enterprise Empties to Winn/ GreenGoods - the sale of Green themed products, a beverage container recycling program (Empties to Winn)

- **Volunteer Services** the maximization of human resources through ongoing recruitment and direction of volunteers in all programs and fundraising activities

# Thank you to all of our amazing supporters and donors this past year

With your generous support, in the 2018/19 fiscal year, we received over \$120,000 in general donations, \$46,000 of which was raised through our Annual Blitz mail out campaign, alone! Our 1st Annual Joey Moss & Friends Golf Classic was held to celebrate WSA's 65th Anniversary and Joey Moss' 55th Birthday. The event raised over \$42,000 in its first year.

In April 2018 the Winnifred Stewart Foundation established an endowment fund with an initial \$100,000 investment with the Edmonton Community Foundation. The creation of the Winnifred Stewart Association Endowment Fund will help to ensure the future sustainability of the Association and ensure it can continue to support individuals with developmental disabilities to meet their potential and have full lives in an inclusive, supportive community. The Green Good program had over 10,000 sales this past year. Our call centre continues to offer the repurchase of product to our 700 business accounts and 6,000 residential customers who have supported us in many cases for over 25 years.

The Empties to Winn program has collected and recycled over **55 Million containers** since the program began in 2007. We collected 6,158,916 ten and twenty-five cent containers this past year.

We are so thankful for the incredible support our ETW program received from the community this year. including the new vehicle donated by Go Auto and the ETW office space provided in-kind by New Star Capital, located next to the bottle depot in the Windermere community.

Thanks to all of the support and generosity of our supporters, the Winnifred Stewart Foundation was able to provide **\$150,000** to the Association for the upcoming fiscal year to fund some much-needed renovations to some of our houses.

We take great pride in ensuring the homes that the people we support live in are homey, comfortable and inviting, while also being adaptable to each person's unique challenges. None of this would be possible without the support we receive from the community. Thank you!
